**Sub: Intimation for Cancellation and foreclosure of Work Order / Contract for Hiring of one no. Private School Bus 54+1 seats capacity for transporting school going children from Sasti Dhoptala Township to various schools of Rajura / Ballarpur in tip top/perfect working condition to ensure trouble free transportation for 240 days in each Academic session on daily rental basis for 2 academic sessions (11 months each session) against the surveyed off of school bus No. MCG 5669. Total traveling distance will be 100 Km per day.**

The work for hiring of one no. school bus (MP 28 P 0247) for transporting school going children from Ballarpur Township to schools of Ballarpur was awarded on Dt: 11-04-2014 for deployment of school bus with effect from 26-03-2014. But you have deployed the bus MH 36 1236 which is not as per terms of work order. The deployed bus MH 36 1236 is in the name of M/s New Goodwill Tours & travels with date of manufacturing 2005 which is a deviation from work order. The notice for non deployment of school bus as per the terms of work order / NIT has been given by referred letter no 593 Dt: 26-04-2015. You have defaulted for non deployment of school bus as per the terms of work order / NIT even after providing sufficient time for deployment of School Bus as per work order. Your contention vide letter no 05 Dt: 09-05-15 to deploy the School Bus for the next session as per work order has not been accepted by the management since you have failed miserably to deploy the school bus as per terms of work order/ NIT.

You have been intimated through this letter by management for cancellation and foreclosure of above referred work order on risk and cost basis as per clause 9 of "conditions of contract" general terms and conditions as per NIT. EMD & Security Deposit (SD) deposited against this tender is forfeited. You are not allowed to participate in the same work while re-tendering.

## ORDER OF TERMINATION AND BANNING

Sub: Communication of decision taken by competent authority in respect of the work of "Hiring of one no. Private School Bus 54+1 seats capacity for transporting school going children from Sasti Dhoptala Township to various schools of Rajara / Ballarpur in tip top/perfect working condition to ensure trouble free transportation for 240 days in each Academic session on daily rental basis for 2 academic sessions (11 months each session) against the surveyed off of school bus No. MH 34 A 3117. Total travelling distance will be 200 Km per day."

The work for hiring of one private school bus for transporting school going children from Sasti Dhoptala Township to various schools of Ballarpur was awarded to you vide work order no WCL/BA/AGM/E&M/2013-14/3040 Dt: 21-03-2014. On your request, vide letter Dt: 07-08-2014 regarding change of vehicle, approval was given for Deployment of school Bus no MH 35 K 3866 after submission of School Bus documents and communicated to you vide letter ref no WCL/BA/AGM/E&M/2014-15/2896 Dt: 19-08-2014.

The School Bus no MH 35 K 3866 operating against above work order was detained by Police. FIR was lodged by Ballarshah Police against Shri Sandeep K Gupta, Proprietor of Shree Balaji Travels Gondia. As per details in FIR, Police has verified the documents of MH 35 K 3866 and have mentioned that original school bus MH 35 K 3866 was operating at Poddar International School, Gondia and same School Bus regd no MH 35 K 3866 operating at Ballarpur Area was fraud & fake. Charges have been framed against Shri Sandeep K Gupta, Proprietor of Shree Balaji Travels, Gondia against IPC 420, 468 and 471.

Whereas following undertaking was given by you in the Affidavit submitted in Tender:

3. All documents/credentials submitted/uploaded along with this tender are genuine, authentic, true and valid.

4. If any information and document submitted/uploaded is found to be false/incorrect at any time, department may cancel my Tender and action as deemed fit may be taken against us, including termination of the contract, forfeiture of all dues including Earnest Money and banning/delisting of our firm and all partners of the firm etc.

ORDER OF TERMINATION AND BANNING

It is found that you have deployed the travel/take school bus Regd no MH 35 K 3866 against the Work Order no WCL/BA/AGM/E&M/2013-14/8040 Dt: 21-03-2014 and violated the terms and conditions of NIT /Contract.

The complete matter was placed before the competent authority. The competent authority has approved actions against you as per provisions contained in the NIT /Contract etc. Accordingly, it is hereby informed that the management has taken the following actions against you:

- 1) Termination of Award of Work /contract awarded vide no WCL/BA/AGM/E&M/2013-14/8040 Dt: 21-03-2014 for Hiring of one no School Bus for transportation of school going children from Sasti Dhoptala Township to various schools of Rajura / Ballarpur with Immediate effect.
- 2) Forfeiture of all due including earnest money i.e any due payment to you and EMD and Security Deposit in respect of the work awarded.
- 3) Banning from participation in the future tender floated by WCL Ballarpur Area for the works of similar nature for a period of one year.
