The rates are inclusive of all taxes / levies including works contract tax, royalty, Octroi, LBT and whichever taxes / levies applicable during the construction of the work toll fees etc and stamp duties wherever applicable, except stated otherwise elsewhere

G Completion Drawings

The contractor shall submit "Completion" drawings and operation & maintenance manual duly approved for the entire work to the Engineer-in-charge within -1 (one) month of actual completion of the work. These drawings shall be accurate and correct in all respects and shall be got approved by the "Engineer-in-charge" before submission. Two sets of the "completion" drawings with a soft copy on CD shall be supplied along with the final bill by the contractor.

10. Joint Venture



count Venture (JV) participation is permitted provided number of partners in the joint venture shall not exceed two and minimum participation of one of the cartners shall not be less than 30% and other partener (Lead Partner) shall not be less than 60% in Technical and Financial eligibility criteria. Both the partners of the Joint Venture jointly shall meet the eligibility criteria as stipulated in eligibility criteria. Also both the partners shall be registered in Govt./Semi-Govt. organization in appropriate class and shall have carried out the similar work in cast Members of JV shall be jointly and severally responsible for the performance of the contract. Once formed and qualified, the partners of joint venture cannot be changed until the tenure of the contract.

A company can participate only in one joint venture. Further a company carticipating in joint venture cannot submit separate bid in its own name. Payment under contract shall be made in the name of lead member of Joint Venture only. The other details for qualification of JV are given at paragraph 11.-xi-2.

11. Eligibility Criteria:-

If bidder fails to install the Concrete batch mix plant within the stipulated period, then Initial Security Deposit along with additional security deposit of Rs. 25.00 Lakhs in the form of bank guarantee will be forfeited and his agreement will be terminated. Moreover, he shall be barred from any participation in any tender in Nagpur Municipal corporation for next 2(two) years
 - v) The bidder should owned/leased minimum one fix/slip form paver. The



2. Joint venture for the work shall be permitted as per stipulations incorporated here in below-

Bids submitted by a joint venture of maximum two firms as partners shall comply with the following requirements

- (a) The bid shall include all the information listed in Paragraph 11 above.
- (b) The bid and in case of a successful bid, the agreement, shall be signed so as to be legally binding on both partners.

2 Award Criteria

- A) The owner will award the contract to the Bidder whose Bid has been determined to be substantially responsive to the Bidding document and who has offered the lowest evaluated Bid Price, provided that such Bidder has been determined to be qualified to perform the contract satisfactorily.
- B) The Bidders are eligible to participate in competitive bidding in accordance with the tender conditions for any or all the packages, however maximum two packages (works) out of the 18 packages (works) so far tendered for this project vide tender adv. No. 307/PR/28/12/2015, 331/PR/12/01/2016,356/PR/29/01/2016& 400/PR/26/02/2016 shall be considered for opening of financial bids of qualified bidder with PQ Criteria and the requirement of machineries mentioned in PQ Criteria.
- C) Maximum 4 (four) packages (works) of the above tender notices shall be considered for opening of financial bids of bidder if the machinery available with bidder is twice or more times the required machineries(except batch mix concrete plant & quarry and crusher) as mentioned in the tender document, which shall be owned by him and also shall have sufficient bid capacity available with him (after deducting the amount of bid for which he stands lowest in earlier packages(Works)) as per tender clause 11 (vii) and shall have executed in excess of the quantity of PQC in M-35 grade and above than the qualifying quantity of bid confirming to clause 11(viii) i.e. available balance quantity after deducting the qualifying quantity of the tender for which he is already qualified as lowest bidder in earlier packages(works)shall only be considered for qualification for new package (work).



- D) The tender is liable to be rejected outright if while submitting the same:
- i) The bidder proposes any conditions and alterations in the obligatory condition of the tender
- ii) The following documents are the Obligatory Documents for submission of bid and if not found with technical bid
- 1) The earnest money deposit in the form of DD/Pay order of Nationalized/ Scheduled bank and the NMC EMD exemption certificate. Also it is specifically instructed to bidder not to upload Additional Performance Security Deposit Demand Draft/Pay order with the Technical bid,
- 2) Registration Certificate of Contractor in appropriate class,
- Work Done Certificates of contractor clearly mentioning satisfactory completion
- 4) PQC quantity certificate mentioning the grade of concrete and satisfactory completion, বিনালন সংক্রমণ ক্ষেত্র
- 5) Ownership of documents of machinerles as mentioned in relarge 11(xi),1.
- 6) All required Undertakings mentioned in the tender documents
- 7) Ownership / Lease / Rental Agreements / purchase orders regarding Concrete Batch Mix Plant (Clause 11(iv)), chilling plant, Stone Crusher plant i.e. cone/VSI crusher (Clause 11(vi) and undertaking for procurement of sized metal from the VSI Crusher, undertaking of establishment of Plant within the 30 kms from the work site.
- 8) Ownership/Lease/Rental/Purchase order of Fix/Slip form paver (Clause 11(v)) along with necessary additional security as made applicable.
- 9) The Turn over certificates of civil engineering works with balance sheets certified by C.A.
- 10) All mandatory registrations as per NIT.
- iii) Any of the pages of the tender is removed / replaced or spoiled badly.
- (v) If the offer in words and in figures is not filled in line in appropriate place in Price Schedule
- v) If the specified earnest money in specified form is not paid.
- vi) All corrections or additions or pasted slips are not initialed by the tenderer.
- vii) Any erasing is made in the tender document.
 - viii) The tenderer or in case of firm or company the authorized person does not sign the tender documents in the place provided for the purpose.

The eligibility criteria will be verified at the time of opening of the tender and if satisfies the requirement, then only financial bid will be opened.



3. Acceptance of the tender

- The acceptance of the tender rests with the Commissioner, NMC, Nagpur.

 The right to reject any or all the tenders without assigning any reason there of is reserved by NMC. The tenderer whose tender is accepted will have to enter into agreement in the type and form prescribed by NMC and abides by all the rules tendered there in.
- 3.2 No corrections, additions or alterations in the tender documents shall be made. No special stipulations in the tender document shall be permitted.
- 3.4 If the tendering contractors are a firm or a company they shall in their forwarding letter should mention the names of all the partners of the firm or the company as the case may be and the names of the partners who hold the power of attorney authorizing them to conduct transactions on behalf of the company / firm.
- 3.5 Rules and conditions of the contract are subject to amendments till the time of acceptance of the tender
- 3.6 The notes and conditions stipulated in this notice will form a part of the agreement
- 3.7 If NMC desires to verify any obligatory Certificate produced by the bidder and found the same defaulted, then the Corporation shall forfeit, the full amount of Earnest Money deposited/amount of exemption certificate. Also, for any descripting document asked by the Engineer, the bidder has to submit the same within 24 Hrs. and for non compliance within stipulated time limit, the tender will be liable to rejection.
- At the same time as the owner notifies the successful bidder that the bid has been accepted, the owner will send the bidder an acceptance letter informing the bidder the further necessary line of action including signing of the contract etc.

5.0 For special attention of tenderer

The tenderer is expected to visit the site before quoting the tender and get himself acquainted with the site conditions and site requirements. There may be some local problems which will be required to be tackled by the

tenderer. This project is to be completed in specific time schedule. However if justified reasonable extension of time limit will be granted subject to condition that no extra claims will be entertained.

If bidder is not registered with NMC, he should initiate the process of registration with NMC, and before the execution of agreement with NMC for the work he shall get himself registered with NMC in the appropriate class. Bidder should provide a brief description of themselves and history of business in past 5 years

- 6.0 All works proposed to be executed under the contract shall be notified in a form of notice inviting tender (NIT).
 - The form will state the work to be carried out as well as the date of submitting and opening tenders and the time allowed for carrying out the work also the amount of earnest money to be deposited with the tender and the amount of the security deposit to be deposited by the successful tenderer and the percentage if any to be deducted from bills
- 7.0 In the event of the tender being submitted by a firm, it must be signed by each partner thereof and in the event of the absence of any partner it shall be signed on his behalf by a person holding a power of attorney authorizing him to do so
 - i) The tenderer shall pay along with the tender the required earnest money deposit in specified form. The same may be paid in the specified form as per NIT.(Notice Inviting tender)
 - ii) The said amount of earnest money shall be appropriated towards the amount of initial security deposit payable by him under the conditions of General Conditions of Contract.
 - iii) If after submitting the tender, the tenderer withdraws his offer or modifies the same or if after the acceptance of his tender the tenderer fails or neglects to furnish the balance of initial security deposit within specified time without prejudice to any other rights and powers of the corporation here under or in law, the corporation shall forfeit the full amount of the earnest money deposited by the tenderer
 - iv) In the event of his tender not being accepted the amount of earnest money deposited by the contractor shall be refunded if applied, no interest whatsoever is payable on this account

CONTRACTOR

- The Commissioner or his duly authorized officer shall open tenders in the presence of the tenderers who have submitted their tenders or their authorized representatives who may opt to remain present at the time. In the event of tender being rejected, the Engineer shall refund the amount of the earnest money to the tenderer as specified earlier.
- 9.0 No receipt for any payment alleged to have been made by a bidder in regard to any matter relating to this tender or the contract, shall be valid and binding on unless it is signed by Executive Engineer or his authorized officer.
- 10.0 All works shall be measured by standard measure and according to the rules and practice in the corporation and without reference to any local practices.
- 11.0 All corrections and additions or posted slips should be initialed.
- 12.0 The measurements of work will be taken according to the usual methods in use in the corporation and no proposals to adopt alternatives will be accepted. The Executive Engineer's decision as to what is the usual method in use in the Nagpur Municipal Corporation will be final.
- 13.0 The tenderer shall furnish a declaration along with the tender showing all works which he has already entered into contract and the value of the work that remains to be executed in each case on the date of submitting the tender and certificates there of shall be duly signed by the officer not below the rank of Executive Engineer
- 14.0 The contractor shall have to construct a shed for storing controlled and valuable materials procured by him for work at site having double locking arrangement. The material will be taken for use in the presence of the departmental person. No material will be allowed to be removed from the site of works.
- 15.0 Successful tenderer will have to produce to the satisfaction of the accepting authority a valid and current license issued in his favour under the provision of Contract Labour (Regulation & Abolition) Act 1970 before starting the work, failing which acceptance of the tender will be liable for withdrawal and the earnest money will be forfeited by N M C

16.0Priority of Contract Documents

The several documents forming the Contract are to be taken as mutually explanatory of one another, but in case of ambiguities or discrepancies the same shall be explained and adjusted by the Engineer who shall there upon issue to the Contractor instructions thereon and in such event, unless



otherwise-provided in the Contract, the priority of the documents Forming the Contract shall be as follows:

- The Contract agreement.
- II) The letter of acceptance
- III) Addendum /Corrigendum to the tender
- IV) General and Special Conditions of Contract
- V) Technical specifications
- VI) Bill of Quantities...

17.0Decision in case of disputes

The decision of the Chief Engineer/Superintending Engineer, NMC shall be final in case of any dispute and same shall be binding on all

18.0Corrupt or Fraudulent Practices

The NMC requires that Bidders / Contractor or his supplier under contracts, observe the highest standard of ethics during the procurement and execution of such contracts in pursuance of this policy as NMC Defines for the purposes of this provision. The terms set further as follows:

- i."Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution, and
- influence a procurement process or the execution of a contract to the detriment of the employer, and includes collusive practice among Bidders (prior to or after Bid submission) designed to establish Bid Prices at artificial non-competitive levels and to deprive the employer of the benefits to free and open competition.
- iii. Will reject a proposal for award if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- Will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a contract if it any time determines that the firm has engaged in corrupt or fraudulent practice in competing for, or in executing, a contract
