tender with JV got qualified for work & issued the work order thereby making hands with concerned authority in name of M/s. D.C. Gurbaxani JV without mentioning JV partner name. thus the authority violated this by issuing phase II work order No.6/ C C RD/2016 dt. 28-07-2016 contract amount 11,19,48,662/- For package No.17 & package No.18 work order No.5/ C.C RD/2016 dt.28-07-2016 contract amount 9,74,66,913/only in name & style of M/s. D.C. Gurbaxani JV.

action of a public official in the procurement process or in contract execution; and ii."Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the employer, and includes collusive practice among Bidders (prior to or after Bid submission) designed to establish Bid Prices at artificial noncompetitive levels and to deprive the employer of the benefits to free and open competition. iii. will reject a proposal for award if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question. iv. Will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a contract if it any time determines that the firm has engaged in corrupt or fraudulent practice in competing for, or in executing, a contract.

UTIB0001828. the authority concerned to make the payment violated the tender norms & hence responsible authority should give reply for this irregularity

Notes: The contractor M/s. D.C Gurbaxani had violated tender norms & adopted corrupt practice for getting allotment of work under package 17 & 18 mentioned above with hands of concerned authority and for getting further benefit of qualification for upcoming cement concrete roads tenders, the department had favored the bidder there by alloted the further work tender to M/s. D.C Gurbaxani on single bid. Hence both M/s. D.C Gurbaxani for getting allotment of work package No. 17 & 18 of cement concrete road is liable for action under relevant law of constitution of India. And also the authority concerned is liable for action under relevant law of constitution of India.
